TODD HENLEY NAMED RECREATION

DEPARTMENT DIRECTOR -- Portsmouth City Manager Karen Conard and the Portsmouth Recreation Board are pleased to announce the selection of Todd Henley as the new Director of the Recreation Department for the City. He returns to the Portsmouth Recreation Department, where he worked for ten years at the beginning of his career, from the Town of Kittery where he has worked for the Kittery Recreation Department/Community Center for the past 13 years. He has served on the Portsmouth Recreation Board for the past 11 years. "Out of a pool of more than sixty applicants, Todd Henley stood out for his institutional knowledge and understanding of both the Portsmouth Recreation Department and this community," said Conard in making the announcement. "Additionally, we believe his connection to the local Arts community through his role as the Kittery Community Center manager will greatly assist him in his new role, and will complement his broad base of relationships in the City and the region. The Board, search committee and I agree that Todd is the best person to honor the legacy of Rus Wilson and to develop this position and this important City Department."

- Portsmouth Senior Activity Center, 125 Cottage St (any time -- envelopes located under the canopy)

2. Return tax package to Senior Activity

Center. Instructions and list of what to bring for the intake interview with the tax counselor are included in the tax envelope. 125 Cottage Street (COAST Bus #40), Sundays 12 noon - 1 pm. Mondays 10 am to 12 noon.

3. Intake Interview – a tax counselor will contact you for an intake interview.


SAGAMORE AVE SEWER EXTENSION PROJECT WORK FEB 22-26

As part of the Sagamore Avenue Sewer Extension Project, borings are needed to collect data about the soils and bedrock in the project area. **Work is scheduled to take place Monday, February 22 through Friday, February 26, 8 am to 3:30 pm, weather permitting.** The work area includes Walker Bungalow Road at the Shaw Road intersection, and sections of Sagamore Avenue and Wentworth House Road. The work will take place on one side of the road, leaving one lane for traffic; but some delays may be expected. Everyone receiving the first dose now receives a vaccination card that includes a scheduled appointment for Dose 2. All you need to do is show up for Dose 2. If you need to change that appointment, you can do so by calling 2-1-1.

AGE 65+ VACCINATION APPOINTMENT WEBSITE -- Scheduling an appointment online at <u>https://vaccines.nh.gov</u> is the fastest, most efficient way to do so and is highly encouraged. The website is designed to handle 100,000+ people at the same time.

For those unable to schedule an appointment online, the 211 Hotline remains available, 7 days a week, 6 am to 10 pm. That call center is staffed by 300+ people, but high wait times are expected.

Those 65+ who do not have Internet access and need assistance can call Brinn Sullivan [603-610-4433] at the Portsmouth Senior Activity Center. Please note that the City is not setting up vaccination appointments. Brinn is simply available to help seniors over the telephone to register on the State website. Brinn is also assisting seniors who need transportation to the local vaccination sites.

PERMITS FOR OUTDOOR DINING & DOMES/IGLOOS- APPLICATION PROCESS

NOW OPEN -- City staff started reviewing and renewing applications for the 2021 outdoor dining season as of February 1.

• Those approved for the 2020 season DO NOT need to reapply. They will be contacted

directly by the City to renew their licenses for the upcoming season.

- Businesses who were not approved in 2020 and wish to operate an outdoor cafe on public property in 2021 must apply for approval by submitting an application through the City's Viewpoint online permitting portal. https://portsmouthnh.viewpointcloud.com/categ ories/1076/record-types/6431
- Anyone opening a new restaurant, is an existing restaurant that is expanding or adding an outdoor area on private property, or who seeks to place tables, chairs or signage on a public sidewalk with no food or alcohol service, please click here for more information.
