PORTSMOUTH PUBLIC LIBRARY RETURNS TO LIMITED IN-PERSON SERVICES APR 5 --

Beginning Monday April 5, the library will bring back in-person browsing, with up to 20 visitors in the building at a time and will also re-open the outdoor book drop. Beginning April 11, the Library will be open on Sundays from 1 to 5 pm. Other hours during the week will remain the same. Public computers will be available for use 30 minutes a day for up to 4 people at a time, and "curbside pickup services" will continue, either in the library café, or outside by appointment for those who do not wish to enter. Study carrels, study rooms, and meeting rooms will remain unavailable at this time. For more details and information about all the services offered online throughout the pandemic, click here.

NH RENTERS ASSISTANCE -- The New

Hampshire Emergency Rental Assistance Program (NHERAP), a state program powered by federal funds to help cover rent and utilities for households struggling due to the impact of COVID-19, launched earlier today. Applications are available on the Community Action Partnership of New Hampshire website at caphh.org and through the Southern NH Services website: https://www.snhs.org/ SNHS can also supply paper applications if you call SNHS at (603) 668-8010 extension 6311. SNHS is also offering assistance for anyone needing help filling out an application. Eligible households can receive 12 months assistance to cover rent, utilities and other housing-related costs. The NHERAP will pay grants to the landlord or utility provider directly on behalf of the household. With permission from their tenants, landlords can assist in applying for relief.



COVID-19 VACCINE ADMINISTRATION IN NEW HAMPSHIRE – As of March 15, NH had received 565,165 doses of vaccine and had vaccinated 460,696 (25% of the population age 18 or older have received 1 or more doses). SCHOOL STAFF AND CHILDCARE PROVIDER VACCINATIONS REGISTRATION WEBSITE OPENS MAR 17 – For school staff and childcare providers not already covered by the vaccination clinics provided by many local SAUs, NH's Vaccine &

Immunization Network Interface website ("VINI") will open on Wednesday, March 17 with appointments starting March 22. For details, visit. https://www.vaccines.nh.gov/

Vaccination registration opens to those age 50 and older on March 23 with the first appointments starting March 25.

AGE 65+ VACCINATION APPOINTMENTS --

Scheduling your Dose 1 appointment online at https://vaccines.nh.gov

is the fastest, most efficient way to do so and is highly encouraged. Those 65+ who do not have Internet access and need assistance can call Brinn Sullivan [603-610-4433] at the Portsmouth Senior Activity Center.

Everyone receiving the first dose now receives a vaccination card that includes a scheduled appointment for Dose 2. All you need to do is show up for Dose 2. If you need to change that appointment, you can do so by calling the 211 hotline.

OUTDOOR DINING -- PERMIT APPLICATION PROCESS NOW OPEN - The City Council approved the use of public sidewalks, starting March 1. Approved use of public streets will start April 1, weather permitting. The Blue Ribbon Committee to Reopen Portsmouth 2021 is working with Portsmouth High School CTE program to paint the street-dining barricades and build planters for the tops, to create a more pleasant atmosphere. City staff are reviewing and renewing applications for the 2021 outdoor dining season. Those approved for the 2020 season DO NOT **need to reapply**.
