ALERT: NH DHHS ANNOUNCES POTENTIAL COMMUNITY EXPOSURE AT HAMPTON WRESTLING TOURNAMENT MAR 6 – NH

DHHS has identified potential community exposures related to multiple confirmed cases of COVID-19 associated with the King of the Mat Wrestling Tournament on March 6, at the RIM Sports Complex in Hampton, between 5 am and 10 pm. Any individuals who participated in or attended the King of the Mat Wrestling Tournament during those times may have been exposed to COVID-19 and should seek testing. DHHS has conducted contact investigations and is notifying known close contacts directly. However, DHHS is making this public notification because there may be additional individuals at the location during those days and times who were exposed to the coronavirus.

PORTSMOUTH PUBLIC LIBRARY RETURNS TO LIMITED IN-PERSON SERVICES APR 5 --

Beginning Monday April 5, the library will bring back in-person browsing, with up to 20 visitors in the building at a time and will also re-open the outdoor book drop. Beginning April 11, the Library will be open on Sundays from 1 to 5 pm. Other hours during the week will remain the same. Public computers will be available for use 30 minutes a day for up to 4 people at a time, and "curbside pickup services" will continue, either in the library café, or outside by appointment for those who do not wish to enter.

NH RENTERS ASSISTANCE -- The New Hampshire Emergency Rental Assistance Program (NHERAP), a state program powered by federal funds to help cover rent and utilities for households struggling due to the impact of COVID-19, launched earlier today. Applications are available on the Community Action Partnership of New Hampshire website at caphh.org and through the Southern NH Services website: https://www.snhs.org/ SNHS can also supply paper applications if you call SNHS at (603) 668-8010 extension 6311. SNHS is also offering assistance for anyone needing help filling out an application. Eligible households can receive 12 months assistance to cover rent, utilities and other housing-related costs. The NHERAP will pay grants to the landlord or utility provider directly on behalf of the household. With permission from their tenants, landlords can assist in applying for relief.



COVID-19 VACCINE ADMINISTRATION IN NEW HAMPSHIRE – As of March 17, NH had received 607,415 doses of vaccine and had vaccinated 478,758 (25% of the population age 18 or older have received 1 or more doses). The dose balance ensures vaccine for those scheduled to receive first or second doses in the current Phase 1A-1B. AGE 65+ VACCINATION APPOINTMENTS --

Scheduling your Dose 1 appointment online at

https://vaccines.nh.gov

is the fastest, most efficient way to do so and is highly encouraged. Those 65+ who do not have Internet access and need assistance can call Brinn Sullivan [603-610-4433] at the Portsmouth Senior Activity Center.

Everyone receiving the first dose now receives a vaccination card that includes a scheduled appointment for Dose 2. All you need to do is show up for Dose 2. If you need to change that appointment, you can do so by calling the 211 hotline.
