

PORTSMOUTH COORDINATED REPONSE TO SUBSTANCE USE DISORDER (PCR/SUD) --.

The committee was formed in 2019 through the collaboration of former Senator Martha Fuller Clark, representatives from the Portsmouth City Council, the Economic Development Commission (EDC) and Pinetree Institute, a non-profit focused on building trauma responsive communities. The overarching goal of PCR/SUD is to address the gap in coordination and access across the many programs in the area that provide support for addiction prevention, treatment, recovery, job reentry and ongoing support. 

COVID-19 VACCINE ADMINISTRATION IN NEW HAMPSHIRE – As of March 29, NH had received 743,355 doses of vaccine and had vaccinated 602,562 (30% of the population age 18 or older have received 1 or more doses). The dose balance ensures vaccine for those scheduled to receive first or second doses in the current Phase 1A-1B. The Department of Public Works is painting the barricades in anticipation of placing them for in-street dining, possibly next week.
