DPW CONSTRUCTION THIS WEEK



ISLINGTON STREET CORRIDOR DETOUR NOW IN PLACE – Starting TODAY Apr 12 and in place 24/7, inbound *car traffic* detours from Islington to Albany to State to Cabot. Inbound *truck traffic* detours from Islington to Albany to State to Summer – or stays on Rte 33/Middle Road, all the way inbound to Middle Street. Outbound traffic only on Islington.

BANFIELD ROAD IMPROVEMENT PROJECT

Continuing the effort to make Banfield Road safer by calming traffic and ultimately building a sidewalk, the City is starting work this week to remove trees that will be affected. Homeowners have signed off on their permission to remove trees on their property. Lyman and Sons is starting work Monday to remove the trees that are in the way of the new sidewalk. CAMP FUNSTUFF REGISTRATION **OPENS APR 19** -- The Portsmouth Recreation Department will host Camp Funstuff at the Connie Bean Center/Middle School from June 21 through August 20 (no camp scheduled on July 5). Hours for Camp Funstuff will be Monday through Friday, 7:30 am to 3:30 pm. The camp is open to children who would be entering Kindergarten in September, through grade 5. Camp participation is \$180 per child, per week or \$1,620 for the full 9 weeks. COVID-19 protocols are being required to ensure the safety of children and staff, including wearing masks, hand sanitizer stations and breaks. STAND-BY FOR SBA SHUTTERED VENUE OPERATORS GRANT PORTAL (SVOG)

Shuttered Venue Operators Grant (SVOG) applications experienced some technical difficulties during startup last Thursday. As the SBA works on the program, check the dedicated SBA website, which includes frequently asked questions, video tutorials and other SVOG detail. Potential applicants should register in the federal government's System for Award Management (SAM.gov), as this is required for an entity to receive an SVOG, and reference the preliminary application checklist and eligibility requirements.

DOG LICENSES NOW BEING RENEWED --AND PLEASE DISPOSE OF DOG WASTE

PROPERLY! As required by State law, all dogs residing in the City of Portsmouth must be licensed. Dog licenses extend from April 1 to March 31. For new licenses, click here for more information and the application.

Please make an appointment if you would like to renew in person, as all City services are currently by-appointment-only due to COVID-19 precautions. Please call 610-7245 to schedule an appointment. Dog waste MUST be disposed of properly. DO NOT drop plastic bags with waste into storm drains! The whole purpose of picking up after your dog is to keep waste from polluting the stormwater with excess nitrogen. Take it home and throw the bag in your trash.
