

DEADLINE FRI OCT 1: STATE OF NH BUSINESS REIMBURSEMENT GRANT

PROGRAM -- The COVID-19 Expenses Relief Program for for-profit businesses with expenses related to the pandemic in 2020 and 2021 may be able to receive reimbursement for a portion of those expenses. There are number of costs that could qualify including:

• Rent, mortgage payments and utilities and other costs incurred while closed.

- Additional costs required to reopen your business such as PPE, workforce safety training, structural modifications.
- Increased costs of doing business such as HVAC, supply chain disruptions

PEVERLY HILL ROAD PROJECT PUBLIC NECESSITY HEARDING OCT 14

The Portsmouth City Council will receive evidence and hear public comment relative to the layout of the Peverly Hill Road Improvement Project and the property acquisitions (permanent and temporary easements) to make that project successful. The improvements include the addition of a sidewalk on the north side of the road, a shared-use path for bicycles and pedestrians on the south side of the road, drainage improvements and road layout changes. The project extends from the intersection of Peverly Hill Road and Middle Road to the intersection of Peverly Hill Road and West Road.

The City Council will assemble at 5 pm in the Eileen Dondero Foley Council Chambers to open the hearing and will then conduct a site visit starting at the parking lot of the New Hope Baptist Church at 263 Peverly Hill Road. The public is welcome to attend that site view, although no testimony from the public will be taken at that time. Then the hearing will reconvene in Council Chambers at 7 pm, for purposes of taking testimony and action. Members of the public may participate in person or via Zoom. For the Zoom registration, click here. Impacted and interested property owners, roadway users and all members of the public are welcome and will be given the opportunity to be heard. PROOF-OF-VACCINATIONS:

What should you do if you discover your vaccination is not recorded properly in the NH DHHS database? Or if you need more than your vaccination card because some travel destinations require the full record? Contact NHIIS (NH Immunization Information System) at 603-271-4028, by email at nhiis.support@dhhs.nh.gov or click here for the NH DHHS website https://tinyurl.com/rva3tphc for the immunization information system (NHIIS). On this site, you will be guided in selecting the correction forms for your PCP to verify your vaccine card, DOB, etc. You will need to get the form notarized and before sending it back to NHIIS. Once your record is corrected and you can request an official vaccine and immunization record. This record is the one that would be accepted when travelling if the vaccine card is not enough. I LOST MY PROOF-OF-VACCINATION CARD. NOW WHAT? All vaccination records are kept on file in the CDC National Health Interview Survey (NHIS) system. NH DHHS advises that you can replace a lost vaccination card in either of two ways:

- Download and complete the vaccination card replacement request form here: https://tinyurl.com/4pj4chcz Note that the completed form MUST BE NOTARIZED before sending it back to NH DHHS.
- If your healthcare provider has access to the NHIIS, ask him/her to print out the record directly from NHIIS.
